

Waiver and Release of Liability

In consideration of the risk of injury that exists while participating in "Ini Kos Konamin Tanong Buwis" workshop, and in consideration of my desire to participate in said activity and being given the right to participate in the same, I hereby knowingly and voluntarily enter into this Waiver and Release of Liability.

I hereby acknowledge that I have carefully read this waiver and fully understand that it is a release of liability. I expressly agree to release and discharge WhatMag Inc and all of its affiliates, members, staff, and volunteers from any and all claims or causes of action that I agree to voluntarily give up or waive any right that I otherwise have in bringing legal action against WhatMag Inc. for personal injury or property damage.
